#### The "Best Interest" Principle

The CASA/GAL volunteer is guided by the "best interest" principle when advocating for a child.

This means that the volunteer **knows** the child well enough to identify the child's needs.

The volunteer makes **fact-based recommendations** to the court about **appropriate resources** to meet
those needs and informs the court of **the child's wishes**, whether or not
those wishes are, in the opinion of the
CASA/GAL volunteer, in the child's
best interest.
